

### Outcomes

119 A pragmatic evaluation of a nationwide mental health outreach service in Japan raises more questions than answers

120 The 3D-CAM provides a brief, easy to use, sensitive and specific delirium assessment tool for older hospitalised patients, both with and without dementia

121 The need for nuanced stigma-reduction programmes to improve help seeking for mental health problems

### Psychological interventions

122 A collaborative care approach delivering treatment to patients with depression comorbid with diabetes or cardiovascular disease achieves significant but small improvements over usual care in depression and patient satisfaction

123 Randomised controlled trial of facilitated exercise plus usual care versus usual care only as a treatment for women with a depressive disorder in the first six postnatal months

124 Can mindfulness groups treat common mental health problems? Problematic design and short follow-up fails to answer the question

125 Group cognitive-behavioural therapy may reduce symptoms and impairment in adolescents with attention-deficit/hyperactivity disorder

### Miscellaneous

126 Mindfulness-based cognitive therapy as an alternative to maintenance antidepressant medication to prevent relapse and recurrence in depression

127 Multielement psychosocial interventions for first-episode psychosis are feasible and show promise in generic mental health services

128 Further evidence to support weight loss and lifestyle interventions for people taking antipsychotic medications
